## The Children's Society agrees to offer you:

- A guaranteed charity place in the Virgin Money London Marathon 2022
- A dedicated Challenge Events Team who will communicate regularly with you & support you
- A chance to join our Marathon Facebook group, connecting you with other Team Children's Society runners
- Training support and access to training guides
- A team training day with expert guest speakers
- A free Children's Society running vest
- Cheer points along the route to keep you going
- A post-race celebration where you will receive a well-deserved massage and refreshments.

## My Terms and Conditions:

In acceptance of my Virgin Money London Marathon 2022 charity place for The Children's Society's, I agree:

- I will raise a minimum sponsorship of £2,000 (excluding Gift Aid). All of my fundraising will be paid only to The Children's Society, including any funds which exceed this amount. I will provide any evidence of my fundraising, if asked to do so.
- I will pay 100% of my sponsorship money (online and offline) to The Children's Society by the deadline of 22 May 2022
- I agree to have raised £500 by 12 December 2021 and to have raised £1,200 before 24 April 2022
- I will pay a non-refundable registration fee of £75 & appreciate this helps to cover the cost of my place
- I will register my details to Virgin Money London Marathon when asked, to ensure I receive my console registration, race day information & race number by the organisers.
   Failure to register by the deadline will result in my place being lost
- I will set up an online fundraising page within a week of accepting my charity place & inform The Children's Society of any offline fundraising activities
- I will not collect in any public place without first obtaining a collector's licence from the local authority

- I will not collect on private property (including shops, pubs etc.) without first obtaining the permission of the owner
- I will contact The Children's Society well in advance of putting on any public event
- I will not reproduce The Children's Society logo, but will obtain all fundraising materials direct from the charity
- I will show the charity any material bearing The Children's Society name or logo, or that discusses the work of the charity prior to printing and distribution
- I will ensure that all materials include the text 'Registered charity 221124'
- I acknowledge that The Children's Society cannot take responsibility for any losses made through my event or liability arising from any event I organise
- I will take advantage of the resources & guidance provided by The Children's Society as much as possible & will not hesitate to contact them if I have any questions, problems or need any support from them
- I am responsible for my own fitness, health & safety & am entering the Virgin Money London Marathon at my own risk
- I will immediately contact The Children's Society, if I can no longer take part in the Virgin Money London Marathon 2022
- I will follow the necessary steps as advised by The Children's Society if deferring my place for the following year
