

Free Prize Draw Terms and Conditions

1. By entering the prize draw you are agreeing to these prize draw terms and conditions.
2. The prize draw is being run by ActionAid of 33-39 Bowling Green Lane, London, EC1R 0BJ

Eligibility to enter

3. The prize draw is open to any person with a valid 2019 Latitude festival ticket who does not work for ActionAid and/or is not volunteering for us at the festival.
4. In entering the prize draw, you confirm that you are eligible to do so and eligible to claim any prize you may win.
5. A maximum of one entry per individual is permitted.
6. The prize draw is free to enter.

How to enter

7. The prize draw opens at 09:00am on 25/06/19 and closes at 12:00am on 09/07/19. Late entries will not be accepted.
8. To enter the prize draw you must complete the online application form, providing your name and email address as well as other requested information on the form.
9. ActionAid will not accept responsibility if contact details provided are incomplete or inaccurate.

The prizes

10. The prizes will be as follows:
 1. First Prize: One single prize of a meet and greet with singer/songwriter Neneh Cherry backstage after her mainstage performance on the Saturday 20th (performance starts 6:05pm and ends 7:20pm, subject to change) for themselves and a guest. They will also get a #MyBodyIsMine ActionAid/Artist collaboration T-shirt which they can pick from [the five options](#). (Sizes are in Small and Medium for all types, dependent on stocks at the festival).
 2. Please note that any winner under the age of 18 must bring an adult aged 18 or over as their guest. ActionAid reserves the right to request proof of age (passport or driving licence) from the winner and/or their guest.
 2. Runners-Up Prizes: Three prizes of winning a #MyBodyIsMine ActionAid/Artist collaboration T-shirt. Runners up can pick from [the five options](#). (Sizes are Small and Medium for all types, dependent on stocks at the festival).
11. The winners will be drawn at random.
12. The prizes are non-exchangeable, non-transferable and no cash alternatives will be offered.
13. We reserve the right to substitute prizes with another prize of which is reasonably equivalent if circumstances beyond our control make it necessary to do so.
14. The decision of ActionAid regarding any aspect of the prize draw is final and binding and no correspondence will be entered into about it.

Winner announcement

15. ActionAid will announce the closure of the competition on our Social Media accounts (Facebook; Twitter; Instagram) and state that we have sent the details to the winners.
16. Winners will be notified by 10/07/19 via email and/or by phone as required.
17. ActionAid will attempt to contact winners by email up to two times and/or by phone. If contact is not made, ActionAid reserves the right to choose and notify a new winner.

Claiming the prize

18. Prize winners must claim their prize by attending ActionAid's tent at Latitude festival. The tent is open daily from 10:00am to 6:00pm each day during the festival. Prizes will only be released following proof of identification (We will send a voucher that you can bring to show the T-shirt team).
19. If a winner does not come to claim their prize during the festival, they will lose their right to the prize.
20. If the winner cannot be contacted or has not claimed their prize within the required time limit, ActionAid reserves the right to choose and notify a new winner.
21. The First Prize Winner must attend the ActionAid Latitude tent at 2:00pm on 20/07/19 in order to plan for the meet and collect their prize shirt, if they have not already done so (the shirt can be collected from the ActionAid tent between 10:00am - 6:00 pm any festival day prior to the Saturday if the winner prefers). They must also attend the Main stage on Saturday 20/07/19 as directed by ActionAid staff to meet Neneh Cherry. If the winner (and their guest, if they bring one) are not at the agreed place at the agreed time, the winner shall lose their right to the First Prize and no alternative prize shall be provided.

Data protection and publicity

22. Any personal information that you provide in entering the prize draw will be used by ActionAid for the purposes of administering the prize draw.
23. Winners are expected to participate in any reasonable publicity related to the prize draw which may include the publication of their name and photograph in any media, including social media.
