

## CONTEST RULES FOR BIGGEST LITTLE GOLF BALL DROP:

### 1. How to Enter the Contest:

- a. The Biggest Little Ball Drop contest will begin on 9/23/19 at 4:30 PM and end on 9/23/19 at 5:00 pm. At the above date and time golf balls will be dropped from a helicopter on to a target at Somerset Golf & Country Club.
- b. To participate in the contest, contestants must purchase entry (\$20/entry) for a chance to win at [www.bbbsnn.org/balldrop](http://www.bbbsnn.org/balldrop) or call 775-352-3202. Must be a Nevada resident to participate. Entries are unlimited. Entries will be assigned to available golf ball numbers on a first-come, first-serve basis.
- c. Entrants may be disqualified at the sole discretion of Big Brothers Big Sisters of Northern Nevada.

### 2. Eligibility Restrictions:

- a. The contest is open only to those who reside in the state of Nevada. Employees of Client and Odds On Promotions, their respective affiliated companies, subsidiaries, distributors, dealers, retailers, printers, advertising, and promotion agencies, any and all other companies associated with this contest, and the members of the immediate families or households of any of the above are not eligible. Immediate family shall include spouse, parents, children, siblings, grandparents, grandchildren and any other person residing within the same household
- b. Only one (1) winner per household is permitted in any contest.

### 3. Prizes:

- a. Grand Prize: USD: \$20,000. A maximum of one (1) grand prize will be awarded. If the one (1) available Grand Prize is won in accordance with these Rules, the contest will officially end at the time the Grand Prize is won. If the contestant(s) does not successfully submit an entry that contains ALL of the below criteria with the official guess matching a pre-selected winning sequence IN EXACT ORDER in accordance with these rules, no grand prize will be awarded.
- b. Prior to the contest, five numbers from among the balls sold will be preselected as eligible winners by OOP. The contestant monitor (Big Brothers Big Sisters of Northern Nevada employee) will submit the numbers of any balls that land on the target for verification to OOP immediately following the ball drop. If the number is one of the preselected numbers, the registrant of that ball will win the grand prize.
- c. Grand prize is provided courtesy of Odds On Promotions.
- d. Guaranteed win prizes of \$500 and \$250 will be awarded to the contestants registered to the two balls that land closest to the target, regardless of pre-selected winning numbers. These winning numbers will be determined by contestant monitor (Big Brothers Big Sisters of Northern Nevada employee).
- e. Winners will be notified following the ball drop. All prizes or prize certificates may be picked up at the office of Big Brothers Big Sisters of Northern Nevada, 1300 Foster Drive, Suite 210, Reno, NV 89509. Any prize or prize certificate not claimed within forty-five days of winning will be forfeited by the winner. In the event that a prize or prize certificate is mailed to the winner, it will be with the prior written consent of the winner and therefore, winner assumes the risk of its arrival. Big Brothers Big Sisters of Northern Nevada is not responsible for the safe arrival of a prize or prize certificate.
- f. Contest prizes are not transferable.
- g. Grand Prize winner will receive 1099 IRS Tax form for the value of the grand prize as stated in these contest rules.
- h. Prizes are limited solely to those items explicitly set forth herein and shall not include any and all other expenses, incidentals or taxes that may arise out of the winner's receipt of this prize.

### 4. Selection and Execution:

- a. Decisions of Contest Administrator with respect to the contest are final.
- b. To enter contest, each contestant must fill out an official contest entry form at [bbbsnn.org/balldrop](http://bbbsnn.org/balldrop) clearly stating their name, address, and phone number and will be assigned a golf ball number. At the conclusion of the promotion, Big Brothers Big Sisters of Northern Nevada must be able to submit ALL eligible entries for verification.
- c. In order to qualify for prize reimbursement, a Promotion Official must call OOP's Interactive Phone Verification System and input the contest code and number of a golf ball that is eligible for verification in accordance with these promotion rules.
- d. In the event that a golf ball number, which has been entered for verification, matches a pre-selected winning golf ball number EXACTLY IN SEQUENCE, and all other terms and conditions of the contract have been met, OOP shall reimburse the client the specified prize.
- e. OOP or Big Brothers Big Sisters of Northern Nevada is not responsible for any prize reimbursement resulting from system malfunction.
- f. The memory logs of the Interactive Phone Verification System in conjunction with the Security Envelope shall be the sole determiners of whether or not a contestant is a prize winner. The audio output of the system will not be considered in determining a winner.
- g. The odds of being selected as an official contestant(s) are dependent upon the number of entries received.

### 5. Conditions:

- a. Payment of all federal, state and local taxes are the sole responsibility of the winner. Winners will be required to sign an IRS Form W-9 or the equivalent. Failure or refusal to execute the release will result in winner forfeiting the prize. Photo identification and social security number of the Grand Prize winner may also be required in order to collect the prize

By participating in the contest, the winner or winners (and their guest or traveling companion, if any) agree to have their name, voice, or likeness used in any advertising or broadcasting material relating to this contest without additional financial or other compensation, and to sign a publicity release prior to acceptance of the prize.
- c. A maximum (1) grand prize(s) will be awarded. Grand prizewinner must accept delivery of prize from Contest Administrator, or as otherwise instructed by Contest Administrator. Winners of prizes greater than \$600.00 will be issued a 1099 form reflecting the value of the prize(s) and are responsible for paying all income taxes on prize(s). Pursuant to the liability release, the winners will agree to hold Odds On Promotions, Big Brothers Big Sisters of Northern Nevada, its licensee, their affiliated companies and the officers, shareholders, directors, employees, agents and representatives of each of them harmless against any and all claims or liability arising directly or indirectly from the prize or participation in the contest.
